DEFINITIONS

Housestaff/Residents and Clinical Fellows: Housestaff/Residents and Clinical Fellows will normally have an MD, DDS, DMD, DO, MBBCh, or MBBS degree and be assigned in a patient care or advanced clinical work or research in a specialized patient care environment for training. Salaries of individuals in this category should be consistent with the Association of American Medical Colleges (AAMC) or Commission on Dental Accreditation (CODA) guidelines for persons with comparable backgrounds and experience. Appointment of these individuals will normally be for one year, renewed annually, until completion of training program as specified by the individual department.

PROCESS & PROCEDURES

Housestaff/Residents and Clinical Fellows may be placed on the Augusta University exempt payroll in non-classified positions. The Program Director, Department Chair, Dean, and/or Department Administrator will be responsible for determining qualifications, identifying the funding required for positions, advertising vacancies, selecting individuals to fill vacancies, and issuing appointment letters and submitting appropriate employment related documentation, i.e. Electronic Personnel Action Request, to Human Resources. Human Resources will be responsible for payroll processing, maintaining personnel files, and administering applicable fringe benefits when available.
